It is occasionally necessary for a student to be transported to school activities in a private or rental vehicle being driven by an authorized student or adult driver. The following requirements apply for authorized use of private or rental vehicles:

- 1. The principal must approve any activity for students who will need to leave the school campus.
- 2. Each driver must have a valid Utah driver's license in order to qualify for transporting students.
- 3. Adult drivers may not drive if they have had a conviction in the past 10 years for an alcohol/drug related driving violation. No one may drive if they have had more than two moving violations in the last 12 months.
- 4. Drivers must have liability insurance coverage on their vehicles as required by state law. The district does not assume this responsibility. A current, valid insurance identification card must be carried in the vehicle at all times.
- 5. Drivers must ensure that the vehicle has passed state-required safety inspections. And the vehicle must have current vehicle registration data.
- 6. The driver must review the USBE Risk Management Defensive Driver test and complete the online test with a passing score. The certificate must be printed and submitted to the District with a copy on file at the school.
- 7. The driver must be at least 25 years of age and complete a background check (Utah Code 53A-15-1503) and the results must be received before the volunteer may drive.
